 - Option #1: Pay in Full by Program Start: Down payment of \$1,000 with remaining balance due by first weekend of the program.
 - Option #2: Payment Program: Down payment of \$1,000 with remaining balance due in scheduled payments according to signed payment agreement. Full payment must be made by the eighth week of the program to obtain your certificate.
 - Unlimited yoga classes during the training period are included in tuition.
 - If you need to cancel your enrollment, it must be done three days prior to the start of the program. A full refund will be processed within 30 days of the request, less the \$200 administration fee.

Missed Weekend: Emergencies and pre-planned events happen and can be made up. Please let the leader know when enrolling the dates you need to miss and arrange the make up hours. You will not receive your certificate until the hours are completed.
