Policies and Procedures

Performer's Packages: Dancers on this package receive a substantial discount therefore 1st month, April and May payments may not be prorated, adjusted, refunded or applied to any other month than the month specified. If you wish to withdraw early, there will be absolutely NO REFUNDS given.

Dancer's Choice: Dancers will be able to cancel at any time by dropping a written notice via email or in person at the studio 7 days prior to the next month. There is a NO cancellation fee.

Extreme Weather or Unexpected Interruption of Classes: No Refunds will be given if the school must cancel classes due to extreme weather or events beyond our control such as power outage.

Substitutions: The school reserves the right to provide a substitute teacher if the regular scheduled teacher is ill or otherwise unable to teach class. If the school cannot arrange a substitute, any missed classes will be made up.

Dress Code: Required dancewear and dance shoes must be worn to all classes. Students are not permitted to wear jeans and for safety, dancers are not permitted to wear jewelry. Only the proper footwear is permitted. NO UGGS, SANDALS etc. Long hair must be tied back. Chewing gum is absolutely not permitted on school premises.

Parent's Responsibility to be Aware of Dates and Events: It is the responsibility of the parent to be aware of all school activities, such as Bring a Friend Week, Parent Viewing Days, Recitals, Photo Shoots, Makeup Classes, School Closings, etc. Starlight will post all updates on StarlightDanceUSA.com and www.Facebook.com/StarlightDancekids Please make sure to LIKE our Starlight Kids Facebook page. It is the responsibility of the parent to inform the school of any address or telephone number change.

Care of students: The school is not responsible for providing before or after class care for students. Parents with students under the age of 5 are to remain in the school during class. Students are not to be left at the school for excessive time before or after class. For your children's safety please keep all children not attending classes off of the dance floor at all times.

Class Rooms: To avoid distractions parents or guardians are **NOT** allowed inside the classroom while class is in progress. For the safety and security of our students taking photos or videos is **ABSOLUTELY NOT** permitted during class. There will be a set day for you to take pictures or videos of your child during the class.

Photo & Video: Starlight Dance Center has my permission to use photographs or videos of my child(ren) to promote the dance studio. I understand that the photos and videos may be used in print publications, online publications, websites, and social media.

Injuries: Parents, legal guardians of minor students and adult students waive the right to any legal action for any injury sustained on school property resulting from normal dance activity or any other activity conducted by the student before, during or after class.
