The Parent / Guardian hereby relinquishes any right that he / she may have to examine or approve the finished product or products or the advertising copy or printed matter that may be used in connection with an image that the Company has taken of the Minor Model, or the use to which it may be applied. The Parent / Guardian waives any ownership and publication right he / she, the Minor Model might be entitled of in connection with the Pictures, with the exception of the personal use of the Pictures as part of the personal modeling portfolio of the Minor Model. The Parent / Guardian agrees he / she has no right to sell, license or publish any of the Pictures taken by the Company to any person or entity.

The Parent / Guardian further releases the Company, its parent company, subsidiaries, affiliates, officers, agents, servants, or employees from any claims for remuneration associated with any form of damage, foreseen or unforeseen, associated with the proper commercial or artistic use of the Pictures unless it can be shown that said reproduction was maliciously caused, produced and published for the sole purpose of subjecting the Minor Model to conspicuous ridicule, scandal, reproach, scorn and indignity.

The Parent / Guardian also waives any and all claims, demands, actions and causes of action whatsoever arising out of or related to any loss or damage of the property belonging to the Minor Model or herself/himself, whether caused while performing the photography session, or while in, on or upon the premises where the photography session was performed.

The Parent / Guardian hereby warrants that he / she is of full age and has every right to contract for the Minor Model in the above regard. The Parent / Guardian states further that he / she has read the above authorization, release, and agreement, prior to its execution, and that he / she is fully familiar with the contents thereof and agree to all of them.

This release shall be binding upon the Parent / Guardian and the Minor Model, and their respective heirs, legal representatives, and assigns.
