## Arts & Crafts Fair Rules & Regulations 2016

### Expanded Show Friday Noon to Saturday @ 4:00 PM

1. Each vendor is required to list all items that will be sold in each booth. All items will be approved on a case-by-case basis. If you sell an item that is not listed, you may be asked to remove the item. If you refuse to cooperate, your booth(s) will be closed and you will be asked to leave. Gross violators of this rule will be eliminated from future participation.
2. No toys with sharp ends will be allowed.
3. All entries received by August 12, 2016, are between \$75-\$125 depending on the product sold. Applicants must send signed entry form and payment by Cashiers Check, Money Order, or Personal Check. We also accept MasterCard/Visa. **After August 12th the entry goes up to \$150 for all vendors.**
4. **Returning vendors have until April 15, 2016, to return their entry forms to ensure they keep the same booth space. After April 15, remaining spaces will become available to all other vendors.**
5. Applicant must furnish their own backdrops, tables, chairs, fans, extension cords, etc.
6. Vehicle passes will be mailed with confirmation letters. Each entry is allowed **1 (one)** vehicle pass. The pass allows you into the park for set up and then **vehicles must be moved out to vendor parking**. If you park in General Admission parking, your vehicle may be towed.
7. Set up time is 8:00 a.m. to 11:00 a.m. on Friday, September 4th. **ALL VEHICLES** must be moved out of the arts & crafts area by 11:30 a.m. If you choose to set up on Saturday only, your booth must be set up by 8:00 a.m. and your vehicle moved to vendor parking.
8. Vehicles will only be allowed back into the fair area after the completion of the event for loading.
9. **NO** four wheelers, bicycles, golf carts, motorized scooters, mules, etc. allowed. **No exceptions will be made, regardless of circumstance.**
10. Arts and Crafts booths will open at 12:00 p.m. Friday to the public. Please make sure to bring enough goods to display for the entire time. Exhibitors must keep their booths open until 4:00 p.m. Saturday.
11. You are responsible for having & displaying a valid sales tax number, and for collecting and submitting sales tax to the State of Texas Comptroller. The Brady/McCulloch County Chamber of Commerce is NOT responsible for collecting or submitting your sales tax. **If sale tax is included in price, please have sign stating so.**
12. **All food items must be prepared in an approved, State inspected kitchen and have ingredient label on their products.**
13. You are responsible for the cleanliness of your space. Any space left in disarray or with loose trash/garbage will disqualify you from future participation.
14. No firearms will be allowed in the Arts/Crafts area. Violators will be asked to leave the area and banned from participation.
15. Gambling is not allowed in the Arts/Crafts area. Violators will be banned from participation.
16. The Arts & Crafts Committee shall be the final authority on interpretation of the rules, regulations, and selection of exhibitors. The Chamber of Commerce reserves the right to reject any vendor.
17. The Brady/McCulloch County Chamber of Commerce shall not be responsible for any accidents, lost, stolen or damaged property, or hurt feelings.
18. Any and all parking violators will be towed at owner's expense. Please adhere to all rules for the safety of our vendors, contestants, and patrons.
19. **The SALE OF ANY ITEMS THAT MAY PROVE HARMFUL IS PROHIBITED.**
20. **NO REFUNDS----RAIN OR SHINE----No exceptions, regardless of circumstance.**
21. We will recognize & award a trophy to the outstanding vendor.
