- 2. No primary food items will be duplicated! HOWEVER, we will not monitor secondary food items.
- 3. Food vendors <u>WILL BE ALLOWED</u> to sell *non-alcoholic* <u>DRINKS</u> of their choice. If you plan to sell drinks, please indicate what you will be serving on your entry form.
- 4. All food must be prepared in an approved, state-inspected facility and must be served according to state regulations.
- 5. Food booths must be set up and ready to sell by 12 pm and be prepared to shut down booths around 5:45, so that electric is not compromised for the lighting of the courthouse.
- 6. You will have **ASSIGNED** booth spaces.
- 7. You are responsible for having and displaying a valid sales tax number, for collecting and submitting sales tax to the State of Texas Comptroller as applicable. The Brady/McCulloch County Chamber of Commerce is NOT responsible for collecting or submitting your sales tax.
- 8. You are responsible for the cleanliness of your area. Any space left in disarray or with loose trash or garbage will disqualify you from future participation.
- 9. No firearms will be allowed. Violators will be asked to leave the area and will not be allowed to participate.
- 10. The Christmas in the Heart Committee shall be the final authority on interpretation of the rules, regulations, and selection of vendors.
- 11. The Brady/McCulloch County Chamber of Commerce shall not be responsible for any accidents, lost, stolen or damaged property or hurt feelings.
