26th Annual Nuclear Conference

I was fortunate enough to attend the 26th Annual IBEW Nuclear Conference in Las Vegas on December 4th, 5th and 6th. This was my first trip to the conference as a Business Representative for our Local Union.

The 3 day event was filled with many speakers from throughout the industry. One speaker was Vicki Bor, an attorney for the IBEW, Scott Sloan and Paul Harris, who works for the Nuclear Regulatory Commission (NRC), spoke on the 10CFR26 Fitness For Duty programs.

One speaker who I found to be the most interesting was Dr. Rosa Yang. She is the Senior Technical Executive for E.P.R.I. (Electric Power Research Institute). Dr. Yang has made seven trips to Japan since the Fukushima disaster, that took the lives of five workers at the plant. She commented that the five deaths were not related to radiation exposure, but to the Tsunami itself. She said that the Japanese are taking steps to protect themselves and their reactors by building walls made of concrete around the plant sites to act as a barrier against future Tsunamis and earthquakes. They hope to have some plants running in the next year, but the decontamination and decommissioning could take up to forty years to complete.

I would like to thank our Business Manager, Tom Koehler, for the opportunity to attend the conference. It was a valuable conference for me.

Federal Regulators OK Power Output Increase At Monticello Nuclear Generating Plant

MINNEAPOLIS - The federal Nuclear Regulatory Commission (NRC) has approved Xcel Energy's application to increase output at Monticello Nuclear Generating Plant to 671 megawatts from 600 megawatts.

"The Monticello nuclear plant currently generates about 10 percent of the electricity we provide customers in our Upper Midwest service territory, and it's carbon-free energy," said Dave Sparby, president and CEO, Northern States Power Co.-Minnesota, an Xcel Energy company. "The increased output will provide additional low-cost energy to our customers."

Karen Fili, site vice president at Monticello, thanked plant employees for their effort in attaining the milestone. "This is good news for our customers, for the Monticello community and for all Monticello plant employees," she said.

Within about a month, plant operators will begin slowly increasing power at small intervals to ensure everything is operating as designed. In addition to the license amendment, Xcel Energy awaits an NRC decision in spring 2014 that will allow more operator flexibility before the plant ascends to the full 671 megawatts.

The Monticello plant, which is about 40 miles northwest of Minneapolis, began operation in 1970 under a 40-year license from the NRC. The NRC subsequently approved a 20-year operating license extension. The plant currently generates enough electricity to power nearly a half million homes.

Senate confirmed Richard Griffin to serve as General Counsel. For the first time in more than a decade, the National Labor Relations Board has a full complement of members and general counsel. "A functioning NLRB is good news for all workers - whether they belong to a union or not - seeking to exercise the rights they are guaranteed by law. These essential rights include the right of workers to stand together and bargain for fair wage, safe workplaces, and other improvements on the job. America's working families applaud the Senate for taking much needed action on all NLRB nominees," declared AFL-CIO head Richard Trumka. Earlier this year, Griffin lost a nomination to the full board as part of the Senate compromise to overcome GOP opposition to a number of President Obama's nominations.

Fifty-four Walmart workers and community, faith and union supporters were arrested during a sit-down protest in Los Angeles in a major demonstration November 9 over the company's low wages and anti-worker policies. They were jailed after sitting down in an intersection outside a Chinatown Walmart before more than 500 cheering and chanting Walmart workers and supporters. Among those taken into custody was Maria Elena Durazo, executive secretary-treasurer of the Los Angeles County Federation of Labor. The action followed a day of strikes by Walmart workers at several Southern California stores. A nationwide protest against Walmart was held on Black Friday, the day after Thanksgiving which has become one of the biggest retail sales days in the U.S. Walmart workers and their supporters held rallies and walkouts at the retail's major facilities across the nation.
