HOW DID YOU GET FROM THERE TO HERE? PROFILES ON THE VOCATIONAL JOURNEY

MEET: KATHI KOEGLE,

Director of Community Relations/ Wisconsin Council of the Blind & Visually Impaired



Chamber member since 2002. Kathi served on the United Way Days of Caring Event planning committee for two years, volunteered at Chamber events, and she has written this column since January 2007. Now, as she "retires" from this activity, it seems like a nice opportunity to turn the tables and interview her! Thank you for sharing your talents with the Chamber!

What path led you to your current job at the Council?

I think deep down inside, I've always been a communicator and connector!

My degrees are in French and Secondary Education, and I taught for four years in a Columbus, Ohio, inner-city junior/senior high school before moving to Pennsylvania and later, Wisconsin. I thought Madison would be the "land of opportunity" for either teaching French or subbing, but there was an abundance of foreign language teachers at that time. I did what a lot of teachers do--I transferred my skills to another professional area. In my case, it was communications and marketing.

After a short stint in radio, I landed a job in 1984 at Saint Benedict Center. My work evolved from part-time telemarketer to full-time director of community relations, which included strategic marketing communications and supervisory responsibilities. When the sisters downsized staff at the end of 2006, my position was

among those terminated. A few months later, I joined the staff of the Wisconsin Council of the Blind & Visually Impaired.

What do you love best about the work you do?

I find great meaning and satisfaction working for nonprofit organizations. While money is important for every organization's survival, it's not the bottom line for most nonprofits.... serving people is. I believe the work I do makes a difference in the lives of others. What I love most is writing about and communicating the Council's mission and vision in the broader community. I also appreciate the many things I've learned about vision loss and the ways people with changing vision courageously manage to maintain their independence, hope and optimism.

Did any one person or experience create a special impression on you professionally?

My supervisor at the newly-emerging radio station in Madison empowered me to do things I never imagined I could. Her confidence gave me confidence! I went from answering phones the first two weeks on the job to writing program collaterals, lining up national guest speakers, preparing interview questions, and producing the show. I grew professionally by leaps and bounds.

What else, in addition to your work, brings you happiness?

My family and dear friends, all things French, cooking, gardening, antiquing, reading, volunteering, and listening to smooth jazz. Oh yes, and beautiful summer days in Wisconsin!

What was it like writing this column?

The funny thing is the way it all began. One day, I told Cecile I'd like to offer my editing help from time to time for Chamber communications. The next day, she e-mailed me and invited me to write a column. When I asked what the subject was, she said, "I'll leave that to you." While enjoying some great chocolate--which often inspires great ideas for me--I came up with the idea of profiling Chamber members and tracing the path that led them to their current work.

Writing this column opened a special window into the lives of some really unique and talented people. I learned about what motivates and inspires them, and I developed a deep admiration for their hard work and commitment to the Chamber. I feel honored that these people welcomed me into their personal lives and shared reflections and insights with newsletter readers. This Chamber is great because its members are great!






