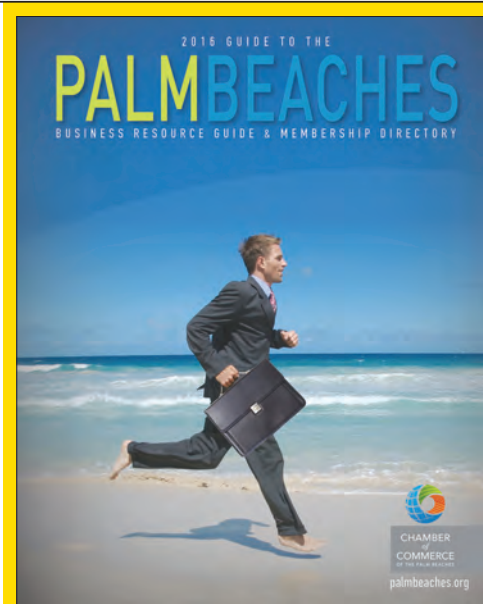

British Consul General in Miami addresses Chamber Trustees



British Consul-General David Prodger addressed the Chamber's Trustees at a Luncheon on the European Union referendum (or Brexit), its outcomes, implications, and forward outlook. Mr. Prodger thanked the Chamber for the opportunity to discuss business in the Palm Beaches and in the broader United Kingdom-South Florida context. He spoke on what the referendum means for the U.K. and its relationship with the European Union, stressing that the U.K. will want the strongest possible economic links with its European neighbors. He highlighted the U.K.'s determination to remain at the heart of global affairs, also mentioning that the U.K.-U.S. special relationship will continue to strengthen and grow.
