Contract Regulations

By signing this contract you, the Buyer(s), have purchased for your dog(s) a membership to Pet Images Dog Park. Buyer(s) agree that the membership fee is non-refundable unless Pet Images Dog Park is no longer able to provide a substantial number of the services offered when this contract was signed, in which case Buyer(s) will receive a prorated refund.

Buyer(s) agree that the membership is not transferable to another dog owner. Other dogs owned by the Buyer(s) may be substituted for those named on the application provided they are approved by the park management.

Buyer(s) may cancel this contract without penalty and receive membership refund within 7 calendar days of the date membership begins. Pet Images Dog Park reserves the right to deny entry to the facility or membership in the facility for any reason, and to terminate membership or expel a person and/or dog from the facility for any reason. If Pet Images Dog Park terminates a membership, the corporation reserves the right to return no refunds.

Indemnity Agreement, Release and Waiver of Liability and Assumption of Risk

Pet Images Dog Park has created a park for dogs and their owners and guests to enjoy together. I understand that the use of this park and other Pet Images Dog Park facilities means that I am taking certain risks of injury to myself, my guests, my dog and my property. I realize that when dogs are around strange people and other dogs, some accidents or injuries may result, and that dogs, people, and property might be injured or damaged.

Any pets that have not passed a previous evaluation with Pet Images professional staff will have to be evaluated at a charge of \$20 per hr. Evaluations by our staff are to help eliminate any aggressive or behavioral problems. This is so all members can have a fun and awarding experience. This does not guarantee that problems may not arise. Members are still responsible for their pet's actions.

Because I want to use and enjoy Pet Images Dog Park and its facilities, I hereby agree to assume these risks for myself, my guests, my dogs and my property. I agree that it is solely my responsibility to determine whether Pet Images Dog Park property itself and any particular situation involving other members, guests and dogs is safe for myself, my guests, my dogs and my property.

In exchange for the opportunity to use Pet Images Dog Park, I hereby release and discharge Pet Images Dog Park and its officers, directors, shareholders, property landlord or appointees or representative and employees from any and all liability, claims, demands, causes of action, loss damage or injury to person or property, including any death or serious injury which may result while I or my guests or my dogs are at Pet Images Dog Park. I also agree to be responsible for my guests and my dogs and for any liability caused by me, my guests and my dogs.

I further agree to hold harmless and indemnify Pet Images Dog Park for any claims, causes of action, or lawsuits asserted against Pet Images Dog Park or its officers, directors, members, and employees that are asserted because of any action or inaction of me, my guests, or my dogs. This indemnification shall include the costs of actual attorney fees and costs.

I have read, understand, and agree to abide by all of the Contract Regulations, Pet Images Dog Park Rules, and the Indemnity Agreement, Release and Waiver of Liability and Assumption of Risk. I understand that Pet Images Dog Park management reserves the right to alter or amend its rules at any time. I intend for this release to be binding upon my heirs, beneficiaries, next of kin, personal representative or executor and assignees.

PET IMAGES COUNTRY INN DOG PARK RULES AND REGULATIONS

- All members must sign in/out at the front office log book
- Watch your dog and keep him or her within your command at all times
- Dogs must be on leash entering/leaving the park. When in the off-leash areas, they must be off-leash, except in the case when you must correct or evacuate the dog. Leashes must be with you AT ALL TIMES.
- No aggressive dogs
- Rough play is fine as long as it is consensual. Rough play and chasing are not acceptable if any of the dogs involved or owners are not comfortable with the situation.
- Dogs must be current on all vaccinations for entry. Rabies, Bordetella and Distemper
- Dog waste must be cleaned up by their owner IMMEDIATELY
- Digging: Do not let your dog dig holes.
- Barking: If your dog is barking excessively, you will be asked to leave the park.
- Children: Children under age 16 must be accompanied by an adult and supervised at all times
- Dog handlers must be 16 yrs. of age
- All male dogs are to be neutered after 6 mo. age Females cannot be in season.
- Food: Nothing edible for dogs or people is allowed in the off-leash areas of the park. Human drinks are permitted. No glass containers
- No smoking allowed in the park/ no illegal substances allowed in the park
- Please do not use splash park to bathe your pets
- If aggressive behavior is observed, take immediate action: move your dog to another area or leave the park. Please report incidents to management. Aggressive dogs must be removed immediately
- Dog fights: To avoid a dog fight, I agree that I can control and command my dog while in the park and I will keep watch over my dog while in the park to insure it is not exhibiting aggressive or antagonistic behavior. I further agree that I will do everything possible to remove my dog from situations uncomfortable to me, my dog, or other dogs or their owners.
- Dogs that are sick, and dogs with obvious external parasites or conditions (e.g. fleas, mange) are not permitted in the Park. Due to the outside nature of the Park, we strongly recommend flea and tick treatments at all times.
