The Results:

29-teams from the Little Traverse Bay Region participated. In 2012 that number was 10, in 2013 that number was 30.

5-teams were from McLaren Northern Michigan in 2014. Down from 13 last year. So, while the overall number of teams was down slightly, more businesses participated than ever before.

In the 10-and under category we had the first place team (RTO&C), four of the five top teams and five of the top ten teams!

In the 11-29 category we had two of the top five, and four of the top ten.

The highest weight loss total by one team was the Health Department of Northwest Michigan Feelin' Fit and Lovin' it Team; they lost 252 pounds.

In all, the 29-teams in the Little Traverse Bay Region lost 1,821.2 pounds!
