Description of the issue

By unanimous vote of the San Rafael Board of Education on July 27th 2015, there will be two bond measures on the November ballot – one for the Elementary District in the amount of\$107,150,000 and one for the High School District in the amount of \$158,500,000. The registrar will issue the ballot letter designations on August 13th, and we will provide those as soon as they are published.

Schedule for the issue to be voted on

Election Day is November 3rd, 2015. Mail ballots (expected to be at least 75% of all ballots cast) will be mailed to voters beginning October 5th, 2015.

Why the SRCC should take such a position. The issue impacts:

i. The San Rafael business community

The business community benefits from a local workforce trained and ready to succeed in the workplace.

Taken together, these two measures will ensure safe and modern classrooms for all of our students in kindergarten through twelfth grade. The funds will enable the Districts to upgrade our schools, classrooms, labs and instructional technology to help ensure that all our students are ready to go on to high school, college, good jobs and the careers of the future.

ii. San Rafael Chamber of Commerce members

In addition to the benefits above, the San Rafael Chamber and Chambers members have a strong history of support for education and partnership with San Rafael City Schools. Support for community investment in additional classrooms, labs and equipment needed to reduce school overcrowding and meet growing demand for hands-on science, technology, engineering, arts and math (STEAM) continues this tradition.
