Nominees for Corporate Citizen of the Year Award must have 50 or more employees and be members of the Greater Seymour Chamber of Commerce in good standing.

RISING STAR AWARD

The Rising Star Award is presented to an individual who has made a positive impact on the community of Seymour. This individual exhibits outstanding citizenship and community involvement, and serves as a role model to all. Nominees for the Rising Star Award must be 40 years of age or less and members of the Greater Seymour Chamber of Commerce in good standing.

CITIZENSHIP AWARD

The Citizenship Award is presented to an individual who has demonstrated exemplary dedication to Seymour and inspires others by their volunteer commitment to the community. This community leader is motivated by their desire to support Seymour and gives freely of their time, talents and energy in local organizations, festivals and special projects.
