Enclosed are the confirmations that Old Republic received from the FMCSA after they filed your revised bond electronically, and our invoice for this year's premium.

Several years ago, the FMCSA mandated that broker bonds be filed electronically. This new system is a significant improvement. Shippers and carriers can verify that a broker has a bond in force any time they want 24 hours per day, 365 days per year. It is vastly superior to relying upon a copy of an old document. The FMCSA will not accept any documents either by mail or electronically. The surety logs in and enters the bond number and the effective date only. The dollar amount of the bond is a default value set by the FMCSA's computer. The surety cannot enter any dollar amount. There are two ways to prove that the bond is in force. First, log into the FMCSA web site at <http://li-public.fmcsa.dot.gov/>. Second, there is a confirmation screen that verifies that the surety has entered the information correctly. A copy of the confirmation screens is enclosed.
